## Minutes of the meeting for the 2<sup>nd</sup> steering committee meeting held at DAIICT on December 14<sup>th</sup>, 2018

2<sup>nd</sup> Meeting of the steering Committee for Anchor Institute Program was held on Friday, Dec 14, 2018 at Admin Building, Board Room from 11.30 AM to 12.45 PM. The following members attended the meeting:

- 8. Dr. Amit Bhatt (Professor, DAIICT) Member Secretary
- 9. Mr. Soman Nair, (Registrar, DAIICT) Special invitee

Following Suggestions / observations were approved by the members of the steering committee

- Members reviewed the details of the courses offered by DAIICT in the winter slot (Nov 15<sup>th</sup> to Dec 20<sup>th</sup>) including course title, total participation in each course, number of faculty members trained by each nodal institute and their feedback regarding the course. Committee expressed satisfaction over the number of courses, total participation and feedback for each course. It was noted that the average feedback for 8 courses varied between 9.4 to 8.4 on a scale of 10
- 2. Members were made aware of the points discussed in the second stakeholders meeting between DAIICT and nodal institute representative) held at DAIICT on 12<sup>th</sup> September 2018. Committee approved opening of bank account by each nodal institute with account name being <"official name of the institute" nodal institute>. Some amount of OpEx can be transferred to each nodal institute to cover for expenses approved by DAIICT.
- 3. CED officials informed the committee that DAIICT should prepare a document detailing utilization timeline of the approved budget as soon as possible for a smooth disbursement of the funds. DAIICT has agreed to this.



- 4. For suggestion of new courses for possible inclusion in the curriculum of GTU as well as other technical institutes run by DTE, Dr Prasad offered to have a joint meeting with the VC of GTU, CED and DAIICT representatives. Similar exercise can also be done with DTE officials.
- 5. Dr Prasad informed the committee regarding scheme 2 floated by the CED known as the "short term bridge courses by industries/institutes scheme". It would require an established teaching institute joining hands with an industry partner to offer a training program in a technical area approved by the CED. Under this scheme, the CED would provide upto 75% of the cost of machinery and equipment including furniture and fixture including the refurbishing of the classrooms. Total cost should not exceed Rs 100 lakhs. Rest 25% of the cost is to be borne by the industry or institute. - 6. It was decided that DAIICT would help CED in identifying 10 such institutes / industries who would be interested in this scheme. CED would help in providing a forum for such interaction
- Dr Prasad suggested that DAIICT should explore offering courses in the area of cyber security to GCCI members. He suggested that DAIICT should contact Mr. Jaimin Vasa – President GCCI
