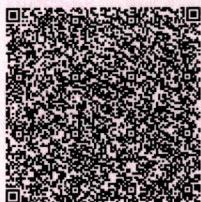
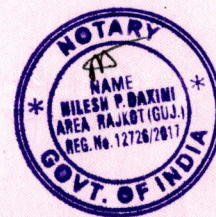

Memorandum Of Understanding

This memorandum of understanding has been finalized, understood and signed on __22nd__ day of __January__, 2021_ between **NSIC – Technical Services Centre (A Govt. of India Enterprise), Rajkot - 360003** hereinafter referred to as the **First party**, and **Gujarat Knowledge Society, Commissioner of Technical Education** hereinafter referred to as the **Second party**, holding its office at Block No.02, 6th floor, Karmayogi Bhavan, Sector10-A,Gandhinagar-382010.

WHEREAS the **General Manager, NSIC – Technical Services Centre, Rajkot (Gujarat)**, is an ISO 9001-2015 certified Government of India Enterprise under Ministry of Micro, Small and Medium Enterprises (MSME). NSIC has been working to fulfill its mission of promoting, aiding and fostering the growth of small industries and industry related micro, small and medium enterprises in the country. The NSIC- Technical Services Centre (NTSC), Rajkot was established in the year 1965 for the support of existing and aspiring entrepreneurs of MSME Sector of SAURASHTRA REGION by providing skilled manpower and testing services through its various skill development training programs and testing facilities in the area of Engine, Motor, Pump, Material testing, Plastic Testing etc. which are NABL accredited and BIS recognized except material testing lab.

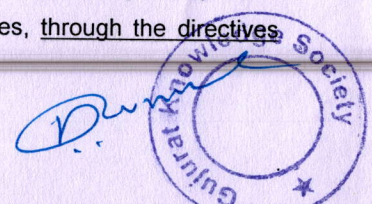
Gujarat Knowledge Society, having its registered office at Commissioner of Technical Education, Block No.02, 6th floor, Karmayogi Bhavan, Sector 10-A, Gandhinagar-382010 Gujarat, is a government organization that provides qualitative and higher level technical training for students from all sorts of financial backgrounds. Commissioner of Technical Education meets global standards of obtaining technological excellence by providing classic methods of technological teaching experience to its learners. The vision of this firm is to root out flaws in this sector, shortening the inconsistencies present in the field and eradicating backward sections of the society from the country by producing exceptionally volatile workers and managers for the socioeconomic development of the nation.

Now under this MoU, following terms and conditions have been agreed upon:

Vocational Training Programme for the Engineering/Polytechnic Students under Integrated Module for Placement cum Training (IMPACT) scheme.

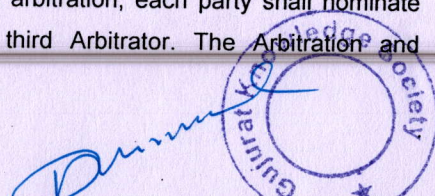
1. THE FIRST PARTY offers training in CNC Lathe - Programming & Operating, VMC - Programming & Operating, AutoCAD, PLC Programming etc and also will offer specially designed short term Vocational Training programme to the Students of Engineering / Polytechnic colleges who are under the control of Commissioner of Technical Education, as per the courses and the contents mentioned in the Annexure I.
2. The Principal of the Engineering / Polytechnic college under the control of Commissioner of Technical Education shall communicate the exact number of trainees with the date of commencement of the course to the **First party** at least one week in advance. The **second party** will provide participants to the **First party** in a year for Vocational Training Programmes, through the directives


issued to the Principals of Engineering and Polytechnic Colleges under its control. The Second Party will provide the fund for the Vocational Training Programmes for Engineering / Polytechnic Colleges students under its control.

3. The standard batch size will be of 20 participants and in any case less than 15 participants will not be allowed. The Training programmes will be conducted at NSIC - TSC, Rajkot and training timings will be of 10 am to 5.30 pm for all working days of NSIC - TSC, Rajkot.
4. THE FIRST PARTY offers all this training program on Non Residential basis only.
5. In case the trainees cause any loss, damage or theft to the equipment during the training the **Principals of Engineering and Polytechnic Colleges** to whom the trainees belong shall make good the damages so caused in full, within one week of receipt of report from THE FIRST PARTY.
6. The training charges will be paid by THE **SECOND PARTY** to THE **FIRST PARTY** within 15 working days of successful completion of training batch at the NSIC –Technical Services Centre, Rajkot and in any case the payment should not be linked to placement of participants. The payment will be made only against the total no. of student, who has successfully completed the training and received the certificates.
7. All passed candidates only will be given completion certificates at the end of the training. No certificates will be issued to unsuccessful candidates.
8. No refund or adjustment will be entertained for unsuccessful candidate or for candidates who leave the Training halfway for whatsoever reason.
9. This agreement will be in effect initially for a period of 2 (TWO) year from the date of signing of this MOU by both the parties and will be renewed further if mutually agreed. Either party may terminate the agreement by written letter signed by the appropriate official of the Institution initiating the notice. Such notice must be received by the other party one month prior to the effective termination date. However, obligations and commitments already contracted for and involving their parties shall be honored and continued by both parties until such commitments are completed.
10. In order to facilitate employment for our trainees THE FIRST PARTY organizes **JOB MELA** in its campus once in three months wherein more than 25 MSMEs used to participate to select suitable manpower for them.
11. Any dispute or difference arising out of this MoU shall in the first instance be amicably settled /resolved between the First party and the Second party within 30 days of reference of dispute. Any such dispute that could not be settled by mutual discussion as above within 30 days after receipt of a notice from either party raising the dispute to the other, shall be finally settled by an Arbitration by appointing a Sole Arbitrator within 30 days jointly by the General Manager, NSIC – Technical Services Centre, Rajkot and THE SECOND PARTY. In case of failure of the parties to agree on a Sole Arbitrator within 30 days of either party notifying the other parties of its intention to invoke arbitration, each party shall nominate arbitration and two arbitrators so nominated shall appoint third Arbitrator. The Arbitration and



Conciliation Act, 1996, shall govern arbitration. The Arbitration shall give reasoned award, which shall be final and binding. The courts of AHMEDABAD shall have the exclusive jurisdiction in all matters under these presents.
